### Cost of Service –\$900-00 (GST Inc.) plus costs and agistment.

Includes – **Booking fee** - \$350-00 (non refundable handling fee)

**Service Fee Balance** - \$550-00 payable upon **compulsory** pregnancy test & in foal confirmation by mare owners vet.

**PLUS Agistment** - \$40-00 per week plus initial worming fee of \$20 upon arrival. Agistment includes meadow hay, grain mix & chaff.

Special dietary & care needs by arrangement may include extra cost. **Agistment Fees must be paid BEFORE pick-up.**

**PLUS Costs** – Fees for of any veterinary or farrier services needed whilst at YSH for service. **Cost fees must be paid BEFORE pick-up.**

### CONDITIONS

- \* Recent, clear photographs showing both sides of mare & a copy of mare's registration papers (if applicable) must accompany mare.
- \* Mare must have vet check no longer than 30 days before arrival at YSH. Copy of inspection report, detailing condition of mare must accompany mare. Mare must have shoes removed.
- \* Agreement includes live foal guarantee. If mare not in foal or no live foal, she must be returned when booking available, a further handling fee applies (\$300 non refundable). Any agistment and costs will apply again. OR BY NEGOTIATION Service Fee balance may be returned if claimed in writing within 30 days of foal due date. (Veterinary proof of loss may be required)
- \* Mare must be picked up within 7 days of end of service period, as informed by YSH.
- \* Mare owner must have a certified vet check mare between 7 to 10 weeks after pick-up to confirm in foal status. Copy of vet report must be sent to YSH.
- \* If mare tests in foal the Service Fee balance must be paid within 14 days of test, sent with copy of vet report. Service certificate will be issued & YSH will send foal return papers to appropriate association upon receipt of this final payment, not before.
- \* YSH will take all reasonable care of the mare whilst at YSH.
- \* Mare must be suitably trained for easy handling. Mares with any handling difficulties or vice such as rearing, biting, kicking, wind-sucking etc will not be accepted. Should it become evident to YSH that a mare has a handling difficulty or vice, the mare will not be served and the owner must pick her up from YSH within 7 days from notice of such. Handling fee will not be refunded & any outstanding vet & agistment fees must be paid BEFORE pickup.
- \* Mare is left at YSH at mare owner's risk.
- \* YSH will endeavor to contact the owner to advise before any vet or farrier work is performed, but in an emergency or if owner is non-contactable, this may not be possible.
- \* Non-payment of monies owing before pickup (Agistment & Costs) will result in mare held by YSH in lieu of payment, further agistment will be charged at \$70 per week & added to outstanding amount. If outstanding fees are not paid within a further 14 days or the outstanding fee total reaches over \$900-00, mare will become property of YSH as payment for outstanding fees. Mare may then be retained or sold on.
- \* Failure to comply with any or all these conditions may result in cancellation of service and non-compliance fee charged (amount at discretion of YSH). YSH retains the right to cancel service agreement at any time.
- \* Mare must be picked up within 7 days of cancellation, agistment and costs apply until pickup and must be paid before release of mare.
- \* Conditions may be modified by negotiation, at the discretion of YSH, & will be confirmed in writing. Copy of changes will be given to Owner.
